

Parent/Guardian Consent Statement

Under the General Data Protection Regulation, United Lisbon International School needs to have the Parent's/Guardian's express consent for each of our students about the collection and processing of their personal data.

Please read this privacy policy carefully, since in access to this form, the availability of your personal data implies the knowledge and acceptance of the conditions contained herein.

Who is responsible for collecting and processing data?

United Lisbon International School (from now "ULIS") is the entity responsible for the collection and processing of personal data and may, within the scope of its activity, use entities subcontracted by itself, for the purposes indicated herein.

What is personal data?

Personal data is any information, of any nature and regardless of their support, including sound and image, relating to an identified or identifiable natural person. Any person who can be identified directly or indirectly, namely by reference or by identification number or one or more specific elements of his/her physical, physiological, psychic, economic, cultural or social identity, shall be considered identifiable. The student's personal data will be obtained during the school year and will be stored in electronic and paper support, which is the responsibility of ULIS.

What personal data are collected and processed?

ULIS collects and processes the following personal student data, among others:

- Name, grade year and school email address.
- Media: images, screenshots, video recordings and video meeting calls.

The data collected are processed and stored in a computerized way and in strict compliance with the legislation on the protection of personal data being stored in a specific database, created for this purpose, by ULIS or the entities contracted by it.

What are your rights?

Under the terms of the Personal Data Protection Act, we guarantee you the right to access, update, rectify, delete, portability and erase your personal data. You may also submit complaints to the National Authority (CNPD).

For how long is the data stored?

The time during which the data are stored varies according to the purpose for which the information is processed. Where there is no specific legal requirement, data shall be stored and retained only for the minimum period necessary for the purposes for which it was collected or later processed, after this time the data will be deleted.

Is the data safe?

ULIS is committed to ensure the protection of the security of this data. For this, we adopted various technical and organizational security measures in order to protect the personal data that it makes available to us against its unauthorized use, loss, misuse, alteration, treatment or access, as well as against any other form of illicit treatment.

ULIS requires its subcontractors and its partners to adopt safety measures equivalent to those it carries out. Notwithstanding the security measures practiced by ULIS, students must take additional security measures, such as ensuring the use of properly configured security-related equipment and browser with active firewall, anti-virus and antispyware, and make sure of the authenticity of the websites visited on the internet as well as avoiding websites whose reputation are not trustworthy.

Data transfer

In case of data transfers to third countries that do not belong to the European Union or the European Economic Area, ULIS will comply with the law, in particular as regards the suitability of the country of destination for the protection of personal data and the requirements applicable to such transfers, and personal data are not transferred to jurisdictions which do not provide security and protection guarantees.

Changes to the Privacy Policy

ULIS reserves the right at any time to adjust or changes to the Privacy Policy. In addition, ULIS ensures the right of access to personal data, as well as to request its rectification and/or erasure.
